GreyStone Power Foundation, Inc. / Operation Round Up Scholarship Fund Criteria

1. The recipient's primary residence must be the household of a GreyStone Power member.
2. The recipient must be enrolled in an accredited program, either full-time or part-time.
3. The recipient may be an undergraduate or graduate student.
4. The scholarship fund will be in the form of a grant program with funds being paid to the college or university.
5. A person may submit an application each year, but previous winners are not eligible for a second scholarship.
6. The scholarship fund will provide for each scholarship winner's educational expenses.
7. The school shall return any unused funds to the scholarship fund.
8. The scholarship may be used at any two-year or four-year accredited college or university.
9. A combination of need and academic ability will be used in determining scholarship fund winners.
10. The GreyStone Power Foundation, Inc. will administer the scholarship fund.
11. Applications will be considered and winners selected by members of the GreyStone Power Foundation, Inc. Board of Directors, which disburses Operation Round Up funds contributed by GreyStone Power members.
12. GreyStone Power employees and employees' family members are not eligible to apply.
