



#### **MILLER'S MINUTE** A STORM TO REMEMBER

Now that summer has arrived, winter and its challenges seem long ago. However, I want to thank you for your patience as GreyStone faced some of the highest weather-caused outages since 1995 due to an early winter snowstorm, and a later tornado, wind and lightning storm that wreaked havoc on our system.

To put it in perspective, during Hurricane Opal in 1995, 97 percent of our system was down following the hurricane's trek through our area. Snowstorm Benji in early December 2017 put more than 50 percent of our members in the dark, our second highest outage ever, and the wind storm in March took out electricity to 19,000 of our members' homes and businesses.

We prepare for scenarios such as these, when poles break, lines come down and transformers are destroyed in widespread areas. It takes time to make repairs, and our methods must be safe to protect both our members and our linemen. Rest assured that getting the power back on as soon and as safely as possible is our singular goal when these conditions occur.

GreyStone Power is removing barriers to solar power! Even the cost is reduced!


The cost for Cooperative Solar's "solar made easy" program has been reduced from \$25 per block to \$22, and GreyStone members can purchase up to two blocks.

Cooperative Solar provides access to solar energy to members who might otherwise be excluded from owning and installing their own solar electricity generation.

As a GreyStone Power member-owner, you can purchase solar electricity according to your needs and interests. Every month, the energy output of your portion will be calculated and credited to your bill. This solar energy will offset energy produced from traditional fuels.

If your block produces more kilowatt-hours than you use during your billing period, you will receive a credit for the excess.

Energy output will vary due to the sun's angle, the time of year and the number of cloudy days in the month. Sign up at www.greystonepower.com/solar.


The 600-member chamber recently began an initiative with strategic partners, including city and county government, the Douglas County Water and Sewer and Douglas County Development authorities, and other local business owners to create a county brand. "We are very diligent about a combined focus and effort on working together," said Pearson.

Wright's goal as chairman of the Paulding Chamber is to leverage Paulding County's assets to recruit employers that will offer jobs leading to careers in areas like health care or advanced manufacturing.

He speaks highly of the new Richland Creek Reservoir under construction and the positive influence it will have on enticing new business to locate in Paulding. He believes another "crown jewel," WellStar Paulding, can be used to encourage more health-related employers to locate near the hospital. "We have a lot of good resources here and more coming," he said.

Wright is especially encouraged about the newly approved Paulding County College and Career Academy, funded by a \$3 million grant from the Technical College System of Georgia. "The Academy will enhance students' work opportunities by developing their job skills to help meet the needs of future employers in Paulding County and the region," he said.

#### **HOW TO BECOME A CANDIDATE**

Eligible members may become a candidate by being selected by the GreyStone Nominating Committee, or by nomination by petition of members. While incumbents Genevieve Cole, District 1; Neal Dettmering, District 4; and Jim Johns, District 8, have been nominated by the Nominating Committee, eligible members may still run by petition.

An eligible member may be nominated by submitting a petition signed by 50 or more GreyStone members of record (the name must appear on the electric bill). The petition along with a Candidate Affidavit must be submitted by Thursday, July 5. Petition and affidavit can be found at greystonepower.com/content/board-elections.

#### NOMINEE REQUIREMENTS

All nominees are subject to a criminal background check, must live within the geographic boundary of the district they seek to represent and must meet all other conditions of eligibility.

Candidates desiring to have their name and biographical information included in the Annual Meeting ballot edition of GEORGIA Magazine must submit information in the format and manner required by the Credentials and Elections Committee by Friday, July 13. ## EARN A \$100 rebate

GreyStone members who own their homes and install an ENERGY STAR smart thermostat, or install an ENERGY STAR-rated HVAC system with a smart thermostat, are eligible to receive a \$100 rebate.

To request a rebate, complete the smart thermostat form found at www.greystonepower. com/rebates. On that page, you can also find a link to view qualifying thermostats.

Smart thermostat technology enables users to remotely control their home's temperature via a tablet, smartphone or computer for greater control using the home's Wi-Fi connection. Additionally, some smart thermostats learn from users' behaviors and begin to adjust settings to match their preferences and schedule.

Some smart thermostats also track weather conditions, your home's energy trends, and monitor the effectiveness of your HVAC system.

Smart thermostats that earn the ENERGY STAR rating are third-party certified to save energy based on field data collected from more than 1,000 homes over an entire year.

Rebates will be paid for 2018 purchases and installations, or until allotted funds are depleted.

# Linemen face the storm aftermath



#### APPRECIATING OUR LINEMEN

They work long hours in the rain, sleet and snow to restore power, sometimes when the lights in their own homes are out. They answer the call when fellow lineworkers in other cities and states face massive outages and spend days away from the comforts of home. They face all the dangers that come with working with electricity, always putting safety first.

In March, a tornado touched down in south Fulton County and storms wreaked havoc on GreyStone's service area, causing 19,000 members to lose power.

Due to that storm, one of GreyStone's own linemen, Line Foreman Terry Queen, had a large pine tree fall on his house. He awoke early the next day to cut his way out of his property so that he could come to work to help restore power for others. Queen (pictured, top right) said thankfully, no one in his family was injured in the incident.

GreyStone Power is thankful for these dedicated employees, and we encourage members and the public to show their support for linemen through the purchase of a special Thank a Lineman vehicle license plate.

Gov. Nathan Deal signed the law to make available a specialty license plate to honor Georgia's electric utility lineworkers, including GreyStone linemen.

Proceeds benefit the Southeastern Firefighters Burn Foundation (SFBF), which assists burn patients and their families at the Joseph M. Still Burn Center at Doctors Hospital in Augusta.

Georgians who are interested in purchasing a Thank a Lineman license plate can visit www.sfbf.net/License-Plate when renewing your annual motor vehicle registration.

In addition, by an act of the General Assembly and Gov. Deal, \$10 of the Georgia Department of Revenue's \$35 annual specialty tag fee for Thank a Lineman license plates will be contributed to SFBF each year when the motorist renews the specialty plate.


