**RATE 3, SCHEDULE "SC"
SMALL COMMERCIAL SERVICE**

Effective Billing Rendered November 1, 2008

AVAILABILITY:

Available in all territory served by the Corporation, in accordance with the Corporation's Service Rules and Regulations.

APPLICABILITY:

Applicable to commercial service and public buildings requiring electric service of one standard voltage required on the member's premises, delivered at one point and metered at or compensated to that voltage, with connected capacity not to exceed 25 KVA and energy usage not to exceed 10,000 kWh in any monthly billing period.

TYPE OF SERVICE:

Service shall be single-phase, 60 cycle and of one standard voltage required on the member's premises and metered at or compensated to that voltage.

UNMETERED NON-SEASONAL SERVICE:

Where the installation of metering equipment is impractical or uneconomical, monthly kWh may be estimated and billed per the parameters of the Rate 3, Schedule of Charges for "SC."

MINIMUM MONTHLY CHARGE:

The minimum monthly charge shall be the sum of the Service Charge, Energy Charges, Environmental Compliance Cost Recovery, Wholesale Power Cost Adjustment, Franchise Fee, and Taxes.

ENVIRONMENTAL COMPLIANCE COST RECOVERY:

The billing, calculated as described in the Rate 3, Schedule of Charges for "SC," shall be increased or decreased, subject to the provisions of the Corporation's effective Environmental Compliance Cost Recovery Schedule.

WHOLESALE POWER COST ADJUSTMENT:

The billing as described in the Rate 3, Schedule of Charges for "SC," shall be increased or decreased, subject to the provisions of the Corporation's effective Wholesale Power Cost Adjustment Schedule.

FRANCHISE FEE:

The billing, calculated as described in the Rate 3, Schedule of Charges for "SC," shall be increased or decreased under the provisions of any applicable Franchise Fee Agreement.

TERMS OF PAYMENT:

The bill is payable upon receipt. A 5% late fee will be assessed on unpaid balances after the due date. Further failure to pay a bill may subject an account to disconnection and charges in accordance with the Corporation's Rules and Regulations.

TERMS OF CONTRACT:

Not less than one year nor more than five years in accordance with the Corporation's Service Rules and Regulations.

Winter – Applicable to bills rendered November through May:

Service Charge: \$15.30

Energy Charges:

First 5,000 kWh \$ 0.108 per kWh
Over 5,000 kWh \$ 0.070 per kWh

Summer – Applicable to bills rendered June through October:

Service Charge: \$15.30

Energy Charges:

First 5,000 kWh \$ 0.108 per kWh
Over 5,000 kWh \$ 0.120 per kWh
