BOARD ELECTIONS

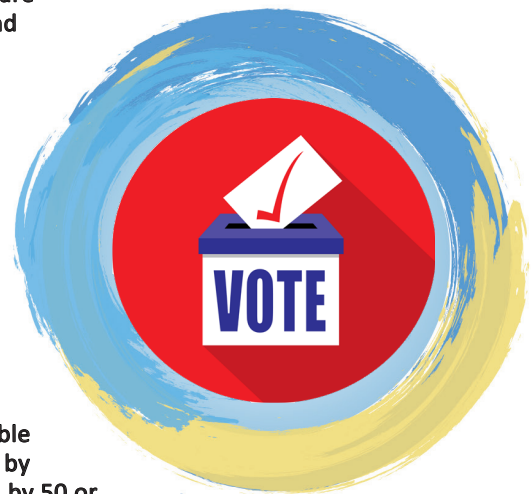
Three seats on the GreyStone Board of Directors are up for election in 2025. The winners will be announced in October following the Annual Meeting of Members.

Eligible members may become a candidate by being selected by the GreyStone Nominating Committee or by nomination by petition of members. Directors seeking reelection this year are Billy Mayhew in District 5 and Charisse Braxton in District 9. The board has solicited candidates to apply to fill an upcoming vacancy in District 3. Director David Hagenow plans to retire from the board when his term ends in October.

The deadline has passed to be nominated by the Nominating Committee, but eligible members may still run by petition. An eligible member may be nominated by submitting a petition signed by 50 or more GreyStone members of record (the name must appear on the electric bill). The petition, along with a Candidate Affidavit, must be submitted by Thursday, July 3. Forms for petition and affidavit can be found at greystonepower.com/board-elections.

All nominees are subject to a criminal and financial background check, must live within the geographic boundary of the district they seek to represent and must meet all other conditions of eligibility.

Candidates desiring to have their name and biographical information included in the Annual Meeting ballot edition of *Georgia Magazine* must submit information in the format and manner required by the Credentials and Elections Committee by Thursday, July 3. 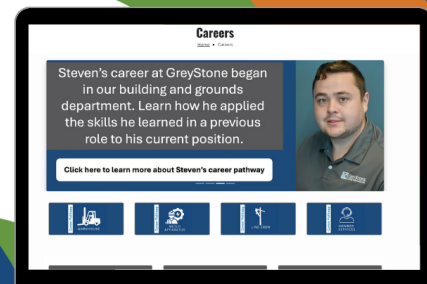
