BOARD ELECTIONS

Three board of directors seats are up for election in 2024. Eligible members may become a candidate by being selected by the GreyStone Nominating Committee, or by nomination by petition of members. For consideration by the Nominating Committee, complete the application and Candidate Affidavit at greystonepower.com. The deadline to complete and return the forms is Friday, April 19.

Directors seeking reelection this year are Genevieve Cole in District 1 (Paulding and Bartow counties); Neal **Dettmering in District** 4 (Douglas and Carroll counties); and Jim Johns in District 8 (Douglas County).

For those seeking to be nominated by petition, 50 or more signatures from GreyStone members of record (the name must appear on the electric bill) and a Candidate Affidavit must be submitted by Thursday, July 4. A petition form and the Candidate Affidavit can be found at greystonepower.com.

All nominees must live within the geographic boundary of the district they seek to represent, are subject to a criminal background check and must meet all other conditions of eligibility set forth in the Bylaws.

Candidates wanting their name and biographical information included in the Annual Meeting ballot edition of Georgia Magazine must submit information in the format and manner required by the Credentials and Election Committee by Thursday, July 4.
