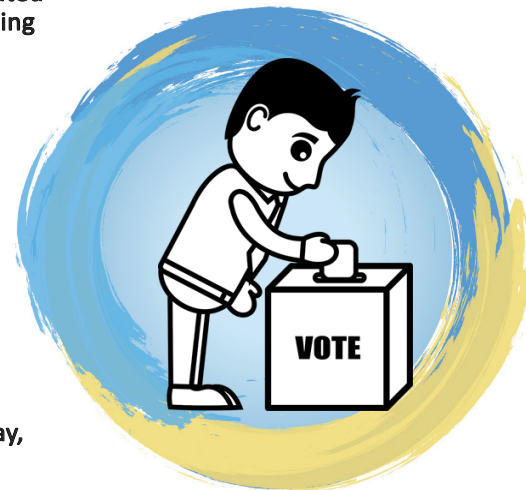
COOPERATIVE SOLAR

BOARD ELECTIONS

Three Board of Director seats are up for election in 2021. Directors seeking re-election this year are Genevieve Cole in District 1 (Paulding and Bartow counties); Neal Dettmering in District 4 (Douglas and Carroll counties); and Jim Johns in District 8 (Douglas County).

Eligible members may become a candidate by being nominated by the GreyStone Nominating Committee, or by a petition of at least 50 members. For consideration by the Nominating Committee, members must submit an application and Candidate Affidavit, which may be found at greystonepower.com. The deadline for the application and Candidate Affidavit is Friday, April 16.



For those seeking to be nominated by petition, the deadline to submit a completed petition and Candidate Affidavit is Thursday, July 1. Petitions must be signed by 50 or more GreyStone members of record (the member of record is the person or entity whose name appears on the electric bill). A petition form and the Candidate Affidavit can also be found at greystonepower.com.

All nominees must live within the geographic boundary of the district they seek to represent, are subject to a criminal background check and must meet all other conditions of eligibility set forth in the Bylaws.

Candidates wanting their name and biographical information included in the Annual Meeting ballot edition of *Georgia Magazine* must submit information in the format and manner required by the Credentials and Election Committee by Thursday, July 1.
