# RATE 100, SCHEDULE "CSR" COOPERATIVE SOLAR RESIDENTIAL

Effective Billing Rendered June 1, 2021

# **PURPOSE:**

The purpose of this Rider is to establish the methods and procedures for determining charges and credits applicable to Members who participate in the Cooperative Solar Program.

# **AVAILABILITY:**

Available in all territory served by the Corporation, in accordance with the Corporation's Service Rules and Regulations. The Cooperative reserves the right to limit the number of Solar Blocks for a Member Participant to no more than two.

### **APPLICABILITY:**

Applicable only for Members taking service under Schedule RS, Residential Service, other than prepaid accounts, who elect to participate in the Cooperative Solar Program.

# **MONTHLY CHARGE:**

The monthly charge shall be \$22.00 times the Solar Block Subscription, less the Excess Energy Credit, if any, and shall be included on the Member Participant's monthly bill under Schedule RS, Residential Service, as the "Cooperative Solar Program Charge."

#### **DEFINITIONS:**

The following capitalized terms shall have the meanings ascribed thereto unless the context clearly indicates otherwise:

- 1. "Member Participant" means a Member of the Cooperative who participates in the Cooperative Solar Program.
- 2. "Billing Period" means, as to a particular Member Participant, the time period between the dates on which the Cooperative reads the retail service meter for billing purposes, generally about a month.
- 3. "Solar Block" means a proportionate share of the total amount of electric energy produced by the Cooperative Solar Program, with the amount of energy associated with each Solar Block determined on a calendar month basis by dividing the total energy produced by the Cooperative Solar Program by the total number of Solar Blocks.
- 4. "Solar Block Subscription" means, for a Billing Period, the number of Solar Blocks to which a Member has subscribed.
- 5. "Member Solar Energy" means, for a Billing Period, the amount of electric energy associated with a Member Participant's Solar Block Subscription for the most recently ended calendar month.

- 6. "Net Energy Consumption" means, for a Billing Period, the amount of electric energy (in kWh) consumed by the Member Participant during the Billing Period, less the Member Solar Energy, but not less than zero.
- 7. "Excess Net Energy" means, for a Billing Period, the amount, if any, by which the Member Solar Energy exceeds the amount of electric energy (in kWh) consumed by the Member Participant.
- 8. "Excess Energy Credit" means, for a Billing Period, the amount of the credit to a Member Participant for Excess Net Energy, if any, and shall be calculated by multiplying the Excess Net Energy times the Cooperative's average avoided cost (in \$/kWh). The avoided cost is listed, but it may be adjusted at any time in the sole discretion of the Cooperative, to reflect the Cooperative's current avoided cost of energy.

Avoided Cost: \$0.02855 per kWh

### **DISPOSITION OF ENERGY:**

In general, the Member Solar Energy will offset, in whole or in part, the amount of electric energy consumed by the Member Participant during a Billing Period, but shall not make the Net Energy Consumption less than zero. For any Billing Period during which the amount of electric energy consumed by the Member Participant exceeds the Member Solar Energy, the Member Participant shall be billed for the Net Energy Consumption under Schedule RS, Residential Service, in lieu of the amount of electric energy consumed by the Member Participant, and the Cooperative Solar Program Charge shall be included on the bill. For any Billing Period during which the Member Solar Energy exceeds the amount of electric energy consumed by the Member Participant, the Member Participant shall be billed for zero kWh under Schedule RS, Residential Service, in lieu of the amount of electric energy consumed by the Member Participant, and the Cooperative Solar Program Charge (including the reduction for the Excess Energy Credit) shall be included on the bill.
